

Information document pursuant to and in accordance with Article 13 of Regulation (EU) 2016/679 (GDPR)

In compliance with the provisions of Article 13 of Regulation (EU) 2016/679 (GDPR), we provide you with the necessary information regarding the processing of personal data.



Processed personal data.

Personal data: any information relating to an identified or identifiable natural person (data subject). An identifiable person is someone who can be identified, directly or indirectly, by specifically referring to an identifier such as name, identification number, location data, online identifier or to one or more factors specific to his/her physical, physiological, genetic, mental, economic, cultural or social identity – see Art. 4, par. 1, (1) GDPR.

- **LEGAL BASIS:** Your explicit consent to the processing of data for this purpose (Art. 6, paragraph 1, letter b GDPR)
- <u>PERSONAL DATA RETENTION PERIOD</u>: until consent is revoked. You may revoke consent at any time by clicking on the "unsubscribe" button contained in any email or newsletter you receive or by writing to privacy@fondital.it.
- <u>THE PROVISION OF DATA FOR THIS PURPOSE IS OPTIONAL</u>. If you do not wish to provide your data, it will not be possible for FONDITAL S.p.A. to keep you constantly updated on offers and promotions reserved for its customers, nor will it be possible to use your data for market research and statistical and customer satisfaction analyses.



3. RECIPIENTS OR CATEGORIES OF RECIPIENTS OF DATA

The data of personal nature provided may be disclosed to subjects who will process the data as processors and/or as authorised persons acting under the authority of the Data Controller, to comply with the existing contracts with the Company or for related purposes. 6. RIGHTS OF THE DATA SUBJECTS

You may assert your rights as expressed in Articles 15 et seq. of EU Regulation 2016/679 by directly contacting the Data Controller at the contacts above.

In particular, You have the right, at any time, to obtain access to your personal data from the Data Controller and request information relating to the processing, as well as to rectify, erase your personal data or restrict their processing and object to the processing carried out pursuant to Art. 6, paragraph 1, letter e) or f) GDPR. Furthermore, at any time, you have the right to withdraw the consent given without prejudice to the lawfulness of the processing based on consent before the withdrawal.

You have the right to portability of your personal data, in which case the Data Controller will provide you with your personal data in a structured format, commonly used and readable by an automated device. In the event that you believe that the processing of your personal data carried out by the Data Controller is in violation of the provisions of Regulation (EU) 2016/679, you have the right to lodge a complaint with the Control Authority - Italian Data Protection Authority (<u>https://www.garanteprivacy.it/</u>).
